Chair's Update

The Chair asks that the commissioners keep in mind the admonition to keep it simple and to continue to provide each other with support. The chair intends to hold a special public meeting to flesh out the Administration of Justice priority for HRC and to continue with Housing as the other area of focus not to the exclusion of other areas of importance as they emerge. The commissioners unanimously agrees.

Citizens Review Committee

Julie and Irene shared that the CPC is an eleven-member Citizen Review Committee (CRC) was created in 2001 to help improve police accountability, promote higher standards of police services, and increase public confidence. Volunteer CRC members are appointed by City Council to perform four primary functions:

- Gather community concerns about police services.
- Help the IPR Director develop policy recommendations to address patterns of problems with police services and conduct.
- Review and advise IPR and IA on the complaint handling process.

Hear appeals from complainants and officers and publicly report its findings.

Their next meeting is Wednesday, August 26 2015 @ 5:30 PM.

A Proposal was made by Se-ah-dom to attend the next CRC meeting and bring a draft proposing an administration of Justice Summit for all of the "C" groups as an opportunity to collaborate and share non duplicative work.

Decision to support group bringing resolution to City Council that would declare: Portland supports closure of Guantanamo; calls on Congress to remove ban on domestic transfer of detainees; and makes known that one or more detainees approved for transfer would be welcome into the Portland community.

A letter of support was approved by the Commission, with a few changes such as "men" to" persons", the addition of Human Rights Declaration article 9 and signed on behalf of the commission by Chabre. Approval of motion

Charles Johnson encourages mutuality for the Commission. And urged them to keep responding to those other intersections that cross with the priority areas that they agreed upon.

Kevin Martionick, thanked the commission for its interest and support and he spoke in support of the Resolution to release and relocation of Guantanamo Bay detainees.
