

What's happening on my street?

Markings all over my sidewalk?

No parking signs put up on my block?!?

Bear with me a bit as this is a complicated question as there does not exist a single database of construction projects and it could be a city crew, a contractor or even work related to a private property construction site. Hopefully we can work together to figure out who is doing the work and get you in contact with an appropriate person to address the situation. A few questions to help me try to figure this out:

1. Do you see any government vehicles associated with the work? (If they are City vehicles they should have the City logo on the side and below that the name of the bureau that it belongs to and a vehicle ID number. If you can get the bureau then we can resolve by get them in contact with an appropriate bureau contact at the City.)
2. Do you see any temporary no-parking signs? (A-board type signs or meter hoods.) If so, they should have a permit label on them that shows the dates of the closure of parking area and the name of the permit holder. (This may help us conclude that this in fact private construction work not a City project. If this is the case they can contact Temporary Street Use Permitting for more information about the permit holder to get in contact with them or they could file a complaint with Work Zone Complaints at PBOT: 503-823-7945, pbotworkzone@portlandoregon.gov)
3. Get an address near the location. (With the address we can lookup in PortlandMaps and the Utility Locate database to see if there are any projects going on in the area)

Scroll down on the right side to the “Permits & Zoning” section and click “Capital Improvement Projects”

What will come up is a list of “Projects” which includes both “Capital Improvement” and “Public Works” projects with ½ mile of the address. These are planned City projects. If you **zoom out on the map** on the left you will see the Capital Improvement Projects populate on the map. CIP IDs starting with **W=Water Bureau, T=PBOT, E=BES**. Sometimes you may find a planned project near to the address that may relate to what the property owner is seeing, however normally with these types of projects the property owners should have received significant communications. If you click on the project ID, in this example “E11219”, it will give you more info about the project dates and also a contact.

The results screen will show everything on that street and then you can scan for the address or a nearby address. In this case 6937 SW 10th shows a couple of recent locate calls just down the street from the City. Clicking on the Ticket # will give you more information including contact info for whomever called it in. In this case it looks there is both some Sewer Repair work and a Gravel Street Project going on just south of their address on SW 10th which could be related to the signage/closures/etc. that your caller is seeing.

4. If none of this results in discovery of a project that may be the source of the markings, signs, blockage, etc. then it is likely an unplanned maintenance project by either PBOT (503-823-1700) or Water (503-823-4874) so check with them.

As you can tell, this can be a lengthy process of discovery so feel free to offer to take the caller's contact information so you, or the appropriate party, can call them back.
