- Motion approved to change multiple references of "citizen involvement" to "public involvement."

Summary of Notes for May 27, 2003

- Primarily discussed changes to City Code Chapter 3.96, Office of Neighborhood Involvement. Motions approved primarily grammatical. Added ONI responsibilities for grievance process and open meeting standards. Also added definition for "Standards".

No updates on Ad-Hoc groups

ONI Code Chapter 3.96

Issues brought up:

- Discussion about grievance language. Is "Establish a grievance procedure" adequate under responsibilities of Neighborhood Associations? Does there need to be a place holder for referencing to the Standards? Concern that some neighborhood associations will have bylaws that do not harmonize with proposed code responsibility about grievances.
- Discussion if we should reference responsibility to follow the whole standards or specifically reference following key sections like open meetings and grievances since those are so important.
 - Suggested changes to Responsibilities of Neighborhood Associations:
 - Section B about public meetings rules: "Neighborhood Associations shall abide by all ONI Standards."
 - Take out sentence #1 on abiding by ORS chapter 192 and replace with: "Neighborhood associations shall abide by the Standards established by the Office of Neighborhood Involvement."
- Consider asking Council to adopt new chapter changes to 3.96 to go into affect upon completion of adoption of standards changes.
- Discussion on responsibilities of city bureaus. Do we keep the place holder for establishing Standards. Unresolved.

- Email out final code draft to large email list and to neighborhood associations.
- Grammar mistakes found:
 - Change references of District Coalition Board and Alternative Service Delivery Structure to Neighborhood Office.
 - Capitalize all references of Neighborhood Association, Neighborhood Office, and Business Associations.
 - Under Responsibilities of ONI sentence D change district coalition boards to "Neighborhood Offices".
 - Capitalize or italicize "Standards."
 - Note last several sections are out of numerical order. Renumber.
