Issues brought up:

- Brian has completed significant outreach through mailing over 150 informational packets to community groups and maintaining contact with Latino Network and APANO. But there has been limited feedback. Most interest is related to the Public Involvement Standards topic and holding City bureau’s accountable to reach out to their communities. Suggestion made that committee staff need to be involved with outreach work. Brian will work to set that up.

Grievances

Issues brought up:

- Committee set up to develop language proposals for Grievance section. Members will be William Warren (chair), Stan Lewis, David Lane, Cathy Crawford, Mark Siebert, Patricia Gardner, Ruth Spetter.

Motion:

Non-Discrimination

Issues brought up:

- Brief discussion on adding “gender identify” to bring Guidelines language up to speed with City Code non-discrimination language.
- Suggestion made to draft language on non-discrimination that includes an outreach component that directs neighborhood offices to assist with outreach to diverse constituencies. Concern raised how can we require volunteers to do outreach if it’s a participatory system in which people get involved based on their own self-interest. As it is associations struggle to recruit anyone to take a leading role let alone continue to ask them to do more work.

Motions:

- Motion approved to add “gender identity” to non-discrimination description.

Benefits of Recognition

Issues brought up:

- Discussion focused on the purpose of the directory of neighborhood association contacts as a primary benefit and primary role of ONI. Lots of suggested language.
- Suggestion to place map of boundaries in the directory.
- Suggestion that ONI needs to be a stronger clearinghouse for all bureau databases of citizen contacts.

Proposals:

- Suggested language:

Neighborhood associations are entitled to receive services including, but not limited to:

1. Placement in the ONI neighborhood directory, which lists the contact information of the Neighborhood Association, its President and/or other neighborhood designated officers and committee chairs. This directory is a public document, which is widely used by the City for public outreach.
2. Notification by agencies of the City as required in the City Code on all matters that fall within the Neighborhood Association boundaries in regard to all planning efforts, policy matters, and decisions affecting the livability, safety, and/or economic vitality of a neighborhood.
3. Did not get to #4 yet.

Motion:

- Motion approved for the following language. Only patial completion of section.
 1. Placement in the ONI neighborhood directory, which lists the contact information of the Neighborhood Association, its President and/or other neighborhood designated officers and committee chairs. This directory is a public document, which is widely used by the City for public outreach.
