The noise variance is for sewer repair work taking place between January 1, 2016 through January 31, 2017 between the hours of 8:00 pm and 5:30 am in the area of NW Vaughn from NW 27 th Ave to NW 23 rd Ave and will require 120-150 nights of variance work during that time. The work will consist of trench cutting and open trench repair work to replace aging sewers and is intended to increase sewer system capacity and help prevent sewer backups in basements.
