1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.

Left Coast Connection has a security guard on premises. There is controlled access to the location including magnetic locks on the entrance, interior doors are locked. The inventory location is locked when not occupied by employees.

The inventory is stored in safes in a secured area. Both the interior and exterior locations are monitored by cameras. There is motion and camera monitoring at all times. Cameras recordings are reviewed on a regular basis for audit purposes.

Employees monitor and escort customers at all times. Customers are not allowed access to inventory unless to inspect prior to purchase.

No person can enter the location unless their identification has been checked and recorded into our system by an authorized person. The location is controlled and secured at all times. All visitors are logged in. Customer IDs and dates are logged into the customer tracking software.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

We have all required posters and educational materials on display in the retail area. We have also offered our support to OHA and OLCC on educational programs.

4. Please describe your plan to ensure that marijuana products sold by your business are not consumed irresponsibly in public or in the immediate vicinity of the license premises.

Left Coast Connections tracks sales and sales quantities to all customers so as to avoid selling excess quantities. Left Coast Connection policy forbids consumption on site by anyone including medical patients.

Security and employees monitor the exterior for customers who may loiter.

If unauthorized activity is discovered, policy is for security or employees to intervene safely and to work closely with law enforcement officials.

5. Please describe your plan to avoid potential negative impacts to neighborhood livability such as noise, parking or garbage from your patrons.

Left Coast Connections has a security guard on site to address any issue that may impact the livability in the adjacent neighborhood. Security and authorized personnel monitor the cameras closely for potential issues.

Left Coast Connection employees regularly police the site for garbage and other debris. There is a locked dumpster on site.

There is both a parking lot with seven spaces and on street parking adjacent to the dispensary.

6. Please describe the process to respond to complaints from neighboring businesses and residents regarding the licensed premises.

Left Coast Connections has a community outreach program, facilitated by the compliance officer. We are proactive neighbors.

If a complaint is received, the policy is to log the complaint into the system and immediately contact a manager or supervisor. The manager then immediately contacts the person to try and rectify the issue if possible.

The compliance officer will then audit the complaint log and follow up to ensure the issue has been addressed
