1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.

Entire building is under 24 hr video surveillance with 30 day DVR recording with a 3 hr battery back up and cellular backup. There are two hand held panic buttons. These devices can be secretly activated to notify the authorities of an attempt to rob.

The door into the sales area is secured with a 600lb magnetic lock that is controlled by the receptionist. They can limit access to the sales area. Once in the sales area the sales staff has control of the exit through the magnetic locking device. Once a sale is completed the staff can allow exiting of sales area insuring that all product is accounted for. All product is inventoried twice a day, once in the morning when product is removed from the 500lb safe that is bolted down and at the end of the day when it is placed back in the safe. This process ensures no product is un accounted for.

Signage is posted at the entrance of building that states that " no one under the age of 21 is allowed on the premises". Identification is checked before entering sales area to insure that no under 21 is allowed into sales area. IDs must be a valid government issued ID. Any one having an invalid ID will be denied access.

- 3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.**

Signage is posted at point of sales stating the risks of marijuana usage by a minor. At the point of sales a 3x5 card is placed in the bag of every sale that explains risk of marijuana use by minors.
