- We have a 24 hour camera monitoring system that records all safes and areas where product is on premises - also all doors. It has a 30 day DVR storage of recordings.
- We do monthly inventory to check for loss
- we have a panic button.
- of robberies, and we have at least 3 employees on staff at all times.
- Our alarm is equipt w/ motion detectors & all of our product and monies are locked in safes at end of night. Alarm system is monitored by Allied Security.
- We also have bars on all 1st floor windows
- all product is behind counter during hours of operation and only one guest per employee is being helped - all other product is out of reach of customers.



2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.

We have a 2 I.D. check system in place.

1st the customer must ring bell to gain access where their Id. is checked for age and validity.

then if admitted the Id goes to the intake desk where information is entered into the computer and the I.D. is checked the 2nd time for proper age and validity.

This is done before any sale is final.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

- We currently hand out the 3XS cards re: health to each customer (placed in bag before leave)
- Signs on walls re: health risks.
- all products in opeg, child proof, re sealable containers.
