1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Posted outside the entrance door is signage that reads, "No Minors Allowed Anywhere on This Premesis"

Upon entering the facility, a Receptionist verifies that the individual has a valid, unexpired, government issued photo identification, and that the individual is at least 21 years of age.

Acceptable valid, unexpired, government issued photo identification may include the following:

- An unexpired and unaltered US state or District of Columbia driver license with or without a photo.
- An unexpired and unaltered identification card or driver license issued by a US state, District of Columbia, Puerto Rico, Guam, Northern Mariana Islands, United States Virgin Islands, or American Samoa with photo, name, date of birth, and physical description.
- An unexpired and unaltered ID card issued by a federally recognized Indian tribe with photo, name, and date of birth.
- An unexpired and unaltered passport or unexpired and unaltered passport card.
- An unexpired and unaltered US military ID card

If the individual cannot produce identification that meets the criteria outlined above (ORS 471.130 and ORS 475B.170) the individual is prohibited from entering and directed to leave immediately.

Visitors to the premises shall be logged in. No one under the age of 21 will be allowed on the premises. the visitor log shall include Viitor name, DOB, identification (driver's license) number, date of the visit, duration of the isit, purpose of the visit, and name of person visiting. visitors who are not authorized (licensed) vendors/contractors shall be excorted at all times by an employee.
