1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Uplift Botanicals understands the importance of preventing unauthorized persons from entering the licensed premises and from gaining access to cannabis items, and it will ensure all representatives and employees are trained thoroughly in following the outlined policy below.

a) Signage. Uplift Botanicals will place signs on the licensed premises that state that no one under 21 is allowed anywhere on the premises and signage that ensures minors do not obtain or cannot attempt to obtain cannabis items. (see below for specific signage policies)

b) Secured Areas. Uplift Botanicals will ensure that all secured areas are locked and under video surveillance during both closed and operating hours.

c) Identification. Uplift Botanicals will ensure that all employees, anyone that enters the premises (except as permitted), and any other licensee or representative or employee of another licensee is 21 years of age or older by verifying valid ID. Valid ID will be considered the following: Passport, Driver's license issued by any State, as long as there is a photo included; United States military ID card, or any other ID issued by a state that contains photo of the person, name, date of birth and physical description.

d) No Free Cannabis; Waste Disposal. Uplift Botanicals will ensure that its representatives and employees are trained to not give away cannabis items to minors. This will include ensuring that non-usable cannabis items are properly disposed of and waste disposal is properly secured.

e) No Loitering. Uplift Botanicals will regularly check to ensure that minors are not loitering around the outside entry of the premises, and if found to be loitering, will be promptly asked to leave.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

Uplift Botanicals' loitering policy will ensure that no patrons outside the premises are consuming marijuana products nearby. Consumption on the premises will be prohibited, which will be broadcast to the public via the signs described above.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

Uplift Botanicals does not anticipate and has not experienced increased noise, parking, or garbage from its patrons. To the extent such negative impacts do exist, Uplift Botanicals intends to limit them by removing loiterers or disruptive patrons from the premises. Uplift Botanicals will provide waste receptacles for non-cannabis materials and will provide secured waste solutions for cannabis materials, of which there will be very little.
