Tru Cannabis is dedicated to protecting our staff and customers at all time. We have 20 cameras that continuously monitor the entire location, including upstairs, downstairs, office, storage, and outside premises. Our cameras record all persons who come into the store and we keep this footage for a minimum of 30 days. We have a 3rd party security company on retainer, as well as a 3rd party monitored alarm system.

Our stores are equipped with 2 panic buttons that all employees are trained on how/when to use. There are always a minimum of two people present on premises during operational hours. Anyone who comes into the shop is required to have their ID checked.

We have continuous employee training related to compliance and security. We also perform quarterly checks to make sure the employees are implementing the training.

Our DVR system is secure to prevent unauthorized access.

2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.

Tru Cannabis is committed to serving our customers respectfully and legally.

Anyone who comes into the store is met in the lobby and carded immediately, before being allowed near the products. All employees are trained to check each customers ID and/or credentials. Damaged, expired, or questionable credentials are not accepted.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

Tru Cannabis is dedicated to the education of our patrons on all issues pertaining to marijuana usage.

Our employees are trained to answer questions from patrons about marijuana and marijuana products, without providing medical advice. While answering their questions, our employees will mention the importance of not providing marijuana to minors.

We also listen to our patrons about their plans for their purchases. If they say they are buying for someone else or for a minor, we will not complete the transaction. That patron will be asked politely to leave the premises.
