1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

Prior to hiring, we will check valid identification to ensure all personnel are at least 21 years old.

We have signs at all points of entry that clearing state, "No Minors Allowed."

During business hours, all employees are trained to check valid identification from everyone upon entry and they verify at point of sale. Everyone checks dates of births and makes sure the individual looks like the picture on ID.

We hand out mandatory OLCC marijuana messaging card that states "It may harm your baby," and "Marijuana can make kids very sick." These cards are handed out at every transaction.

We also have posters hanging up with the same messages to keep marijuana out of reach from children and use of marijuana during pregnancy or while breastfeeding is harmful.

All marijuana products are labeled with "adults 21 and older and keep out of reach of children."

We also have big posters with the same message posted throughout our interior.

All usable marijuana and cannabis products are placed in child resistant containers with warning labels stating "For use by adults 21 and older. Keep out of reach of children." All packaging is OLCC compliant, using approved child resistant containers, labeling, and exit bags.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

All staff are informed there is zero tolerance for consumption on premises per OLCC regulation except if an employee is an OMMP card holder, they are allowed to consume an edible in a private area, behind a closed door. We also do not allow lingering and loitering on property grounds.

We have a sign posted at the entrance that states, "No consumption on premises."

Sold Marijuana products are in a heat sealed package or in child proof packaging, and products aren't easily accessible for immediate consumption.

We continuously monitor patrons at all times while they are within our facility. We make sure patrons are in the presence of our staff at all times.

If lingering or loitering were to occur in parking lot, our staff would stop it immediately.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

Maintaining a positive relationship and safe environment for our neighborhood is a top priority.

We already invested in the property and provided more hedging/plants where people could loiter.

We provide waste and recycling receptacles to discourage littering.

On a weekly basis, staff will walk through property grounds and clean up any litter.

Signage is posted to remind individuals to not consume on premises and state regulations does not allow consumption anywhere in public.
