For robberies we have a panic safe that the employees can lock themselves into that has air flow and a panic lock on the inside. All of the doors in the interior of the buildings have keycard access so that you would have to kick the door down to get past past them. All of the display cases have locks on them. We have a security guard on the premises at all times and we have cameras in all locations of the building.

There is a front desk person that checks all IDs before allowing people to enter the sales floor. The front desk person checks the year of birth and adds it into our computer system so that the budtenders know if it shows up red on the screen, they are over 21 and a recreational customer.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

Every sale to a recreational customer comes with an educational card that tells them the harm of cannabis and children. We also make sure that everything sold is in child-proof containers. We have posters in the building by the registers that also warn customers.

4. Please describe your plan to ensure that marijuana products sold by your business are not consumed irresponsibly in public or in the immediate vicinity of the license premises.

We are having a sign made made for NO CONSUMPTION ON PROPERTY. The security guard walks around the premises and the perimeter of the property every 30 minutes to make sure that noone is using marijuana (or any other drug or substance) on the property or premises. Also, the budtenders tell customers that there is 100% no smoking, topicals, oils, or edibles at or within 1,000 feet from our business premises.

5. Please describe your plan to avoid potential negative impacts to neighborhood livability such as noise, parking or garbage from your patrons.

We don't throw events at the business location and are not outside to make noise. The security guard checks on this to be sure that nobody is making outside noise. We have our staff pick all garbage up and blow leaves off the property 2 times a day, once in the morning and once at closing. We are making a parking lot in the back of the building so that people can have private parking and not use the public street parking areas. We also have bike racks in the front of our building to encourage the use of sustainable biking transportation among our patrons.
