1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.

The Portland Canna Connection will utilize its 16-camera security system, and back-up computers to monitor for burglaries, robberies, and shoplifting. Employees are all trained upon hire to follow the "Store Security" guidelines which outlines the proper procedures to take when theft or robberies occur. This includes the location of our three panic buttons located on the premises, as well detailed instructions for all employees to take when such circumstances occur. The store security system is monitored by Sonitrol Alarm Company and is backed up by a battery (generator) in case of an electrical outage. In the event of a theft, management will play-back and print images of the security footage. All product is locked in secured safes and locked refrigerators to mitigate risk. All employees and customers are cleared of the building at days end as posted on the "Daily Task" document sheet.

2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.

Required signs are posted at the front entrance stating that no person under the age of 21 is permitted to enter the establishment. Upon entering, customers are required to provide identification validating that they are in fact 21 years or older. In addition, every customer's identification is checked a second time at the point of sale system. All employees are required to read the State ID Brochure in order to ensure and verify unfamiliar forms of identification.

3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.

The Portland Canna Connection has posted all state required signs at the point of sale educating patrons of the risks of marijuana use by minors. All useable cannabis products are packaged in child-proof and sealed containers and labeled with appropriate warnings. Employees cue customers regarding risks of marijuana use by minors.

The Portland Canna Connection has 3 external security recording cameras that are monitored by management to ensure there is no consumption in the immediate vicinity. The Portland Canna Connection has also communicated with our neighboring businesses and local residents in order to support one another in mitigating improper consumption.

5. Please describe your plan to avoid potential negative impacts to neighborhood livability such as noise, parking or garbage from your patrons.

Employees of the Portland Canna Connection adhere to our required "Daily Tasks" which include daily sweeps of the outside property in order to collect any garbage and report any problems to management. The Portland Canna Connection has its own reserved parking lot for patrons which eliminates the usage of local resident parking. The Portland Canna Connection has a working relationship with all neighboring businesses and residents in order to support and maintain the surrounding community.
