**1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.**

The store will have secured entrances and exits, and security bars, and camera coverage; the store will meet all OLCC security requirements. Areas where money or marijuana products are kept will have additional security doors, safes and other security features. Recordings from security cameras must be available both on-site and off-site for later review. The store will have a 24-hour monitored alarm system, with panic buttons and motion sensing.

Employees will be trained to handle robbery situations so that nobody is put in harm's way and to avoid confrontations. The security system and cameras will record any robbery and be turned over immediately to the police. Persons will not be allowed to enter the store wearing large hats or hoods that conceal their faces from our cameras.

Marijuana and other products will be kept behind locked display cases during the day, and secured in safes at night. With constant camera footage as well, shoplifting would be difficult.

**2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.**

All customers will be required to check-in at the entrance, where an employee does not let anyone have access without valid government ID. Employees will be trained to look for fake IDs and trained to review each ID and verify the descriptions and photos with the customer presenting it. Employees will have access to a guide to compare out-of-state ID's to. Regular customers must present proper government ID each and every visit, and will be refused entry without it.

Nobody will be allowed to enter the building without presenting proper government ID at the entry station located there. Restrictive 21+ signs must be present on walls inside and outside.

**3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.**

Persons under 21 will not allowed in the building under any circumstances. Security cameras monitor the building's private parking as well, so suspected minors in our parking trying to unlawfully approach customers would be seen - any such activity will be reported to the police.

All marijuana products are required to meet OLLCC requirements restricting packaging and designs that appeal to minors, and all packaging must be child-resistant. Information will be made available at our store to any customer who wants information on safe use and storage of marijuana and tips to ensure children cannot access marijuana products at a customer's home. Employees will be trained to respond to any questions or comments or statements from any customer regarding possible access to or use of marijuana products by persons under 21.
