 Full documentation of products purchased and inventory on a daily basis.  
 Theft by employees is grounds for termination.  
 We have 19 cameras, 6 motion sensors, 2 door sensors, and 3 window sensors.  
 Id's are checked for every individual before they enter the Mercantile area.  
 There is an enclosed security booth to validate ID and the doors are controlled from inside with a magnetic buzzer system. They are solid core doors with steel frames.  
 Five panic buttons.  
 Shoplifting is deterred by having all products in display cases and never have them unattended.
