- Before entering main lobby customers are required to show proof of valid I.D. proving that they are 21+ years old and once more before purchase just to verify they are of age (21+).
- The entrance to the retail area must remain locked at all times and accessed only by authorized personnel with issued keys.
- In addition to the above precautions signs have been placed inside and outside of the premises clearly stating, in English and Spanish, that no minors may be present on the premises.
- Distribution of warning pamphlets, designed by the state of Oregon to every customer upon completing the transaction, these pamphlets are given by receipt or inserted into the exit bags prior to receipt by customer.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

- Prominent signs outside of the dispensary clearly state, in English and Spanish, The consumption of marijuana on the premises is strictly prohibited.
- All employees have been instructed to verbally intercede with any witnessed on-site consumption of marijuana and to remove the offender from the premises immediately.
- Exterior cameras have been added to ensure that employees have visibility around the exterior of the dispensary while assisting customers inside.
- Additionally we have a "Educate before you secrete" poster, provided by the state, which clearly states the current legality with public consumption.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

- Our private, re-painted and ADA compliant, parking lot minimizes the impact of street parking on Sherret Rd and SE 8th Ave.
- The parking lot and store close at 9:55 PM to minimize security risks and noise pollution for our staff and surrounding neighborhood.
- Our staff is instructed to regularly patrol and clean the exterior of the premises, including but not limited to: The parking lot, entrance, sidewalk of 8th and a small stretch of Sherret Rd.
