**1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.**

Stumptown Cannabis is very serious about keeping minors out of our licensed recreational facility at all costs. Outside of the facility individuals are able to read required signage that states no minors allowed on premise. Once the individual enters the outside entry doors they are isolated from the facility in a waiting area with multiple signs in english and spanish that states "No minors allowed on premise". These individuals have no access to the facility without authorization because the waiting area is isolated with locked doors. Our trained staff answers the door and checks the ID of the individual to ensure they are over 21 with a valid ID and the picture matches the individual presenting the ID. Once verified, the individual is granted access to the facility. If the individual does not have ID, has expired ID, or we are unable to confirm the individuals age, they will be asked to immediately leave the premise.

Once the customer has determined what they would like to purchase, they are escorted to the Point of Sale without having access to the marijuana until they provide payment. Once at the POS, the staff member checks the individuals ID a second time before checkout to ensure a ID verification mistake has not occurred. Once the ID has been verified a second time they will proceed with the checkout process. Upon the completion of checkout the customer will be provided with a 3x5 handout explaining the dangers of allowing children to access/consume marijuana or marijuana products. all marijuana and marijuana products are properly protected by childproof packaging and labeled with the red universal marijuana danger symbol to educate individuals that they need to be careful with the product. Required 17X22 posters are posted by the POS educating individuals about risks of marijuana use by minors along with other regulations regarding Oregon Marijuana Laws.

We also sell lockboxes to customers at cost to help keep marijuana secure and out of reach of minors.

**2. Please describe how your business will prevent cannabis products from being consumed around or near your business.**

Any attempted consumption on the premise or in the parking lot is strictly forbidden. We have signs in the lobby and inside the licensed premise that state on-site consumption is prohibited. If there is a individual attempting to consume marijuana in any form on the premise they will be asked to immediately cease their actions and leave the property in addition to informing them again that they are not allowed to consume marijuana on the premise. If the action is not immediately stopped we will inform them that we will contact the police to have them removed from our facility and parking lot.

**3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.**

We actively try to mitigate any negative impacts to the neighborhood livability. Since opening a year ago, we have not received a single complaint regarding noise, parking, garbage or loitering. Customers do not loiter in the parking lot and if they do they are asked to leave. There is no noise pollution outside of the facility from our store. Garbage is picked up from the parking lot daily and kept in a secure garbage fenced area. Since we have 18 private parking spaces, there are no negative parking issues that we cause. If there ever are any concerns, we would immediately address them and figure out how to mitigate any potential negative impact on the neighborhood.
