**1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.**

We have posted signs, Pursuant to OLCC requirements, stating that only individuals 21 years or older or properly licensed OMMP patients under the age of 21 can enter the facility. Everyone that enters the dispensary must show an appropriate government issued ID as evidence of their age, prior to admission to the sales floor area from the lobby.

**2. Please describe how your business will prevent cannabis products from being consumed around or near your business.**

We currently post signage required by OLCC that states that on-site consumption of Cannabis products is prohibited. In addition, posted in the sales area is the OMMP mandated poster that clearly states the prohibition.

All though we are not aware of any of our customers attempting on site usage, we have trained our staff to monitor for this activity. If on site use is discovered, the manager will make contact with the customer and remind them of the prohibition and if the activity does not cease immediately they will be barred from future purchases at our facility.

**3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.**

We want to be a good neighbor, therefore we appropriately police the activities of our patrons and employees to insure that negative livability issues do not develop. We consider ourselves a neighborhood dispensary. In our short experience and from the feedback that we have received from the community, we feel that our presence is welcome.

Fortunately, many of our customers live near us and walk to the dispensary. Notwithstanding our convenient location to our patrons, our location does offer ample on street and off street parking. We have not had any parking issues reported to us by our commercial or residential neighbors. Our neighbors should have a reasonable expectation that we would promptly deal with any noise nuisance. If one of our patrons were to become a nuisance, in any way, our on site manager would contact them and request the offending activity to cease and/or request that they leave the premises immediately. Aside from such issues created by patrons our normal business activities do not generate noise that could be described as a nuisance.

Waste disposal receptacles are provided throughout our facility. Our site is continually monitored and policed by employees to maintain a clean, appealing and safe environment.

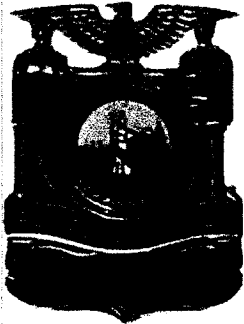
