All OLCC regulations prohibiting minors are strictly followed. No one under the age of 21 is allowed on premises, and required signage is posted indicating that no minors are allowed on the premises. Employees go through training on how to identify a minor.

This store has a waiting area that is not part of the licensed premises. Employees check IDs here before allowing entry onto the premises. In addition to a manual inspection of IDs, employees also use a program that scans the barcode on the ID to ensure the person is over 21.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

The store manager is constantly monitoring the two outdoor cameras to ensure no one is loitering or consuming products on site. Employees are instructed to watch for consumption anytime they are outside of the building (on breaks or any other time). Signs are posted warning that no on-site consumption is allowed.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

A landscaping service comes biweekly to clean up the parking lot and wash the windows of the building. Employees pick up trash and sweep outside the store and in the parking lot on in-between days. Trash is also picked up biweekly. The store has an air filtration in the ceiling, and all products are stored in sealed rubber containers to keep any smell contained. The exterior is constantly monitored for loitering, and loitering is not tolerated. There are signs posted in the parking lot telling customers not to park in the parking lot for the bank next door.
