**1. Please describe your plan to prevent theft at the licensed premises, including robberies, burglaries, and shoplifting.**

Re-Leaf Cannabis Center (RCC) will be equipped with state compliant surveillance cameras to monitor all activity on the licensed premises. The store will also have a security alarm, with a local dispatch center, in the case of a burglary.

To prevent robberies, RCC will have an identification checkpoint before entry into the facility. Doing so will control the number of customers inside the premises. RCC will also have panic alarms throughout the building and the manager on duty, or their designee will have a panic alarm remote access with them during operating hours. Limiting the number of customers inside the store at any given time, so an employee can monitor the actions to prevent shoplifting will also be included.

**2. Please describe your plan to control access to your establishment and ensure that no one under the age of 21 is admitted.**

RCC will have an identification checkpoint. The identification checkpoint will be used for checking that every customer has their identification, and confirming their age from using visually inspecting the identification for fraud, expiration date, and age. The identification will also be subject to being scanned by an identification card reader.

**3. In order to reduce the possibility of underage persons, as established by law, from gaining access to marijuana products sold at the licensed premises, please describe your plan to educate patrons on the risks of marijuana use by minors.**

RCC will have pamphlets and literature on the risks of marijuana use by minors throughout the store and available upon request. A notification of such will also be in a conspicuous space of the store, reminding out patrons of the risk of marijuana use by minors.

**4. Please describe your plan to ensure that marijuana products sold by your business are not consumed irresponsibly in public or in the immediate vicinity of the license premises.**

RCC will have a sign within the store and in the parking lot, reminding customers not to consume marijuana products irresponsibly in public, or in the immediate vicinity of the license premises. The parking area will also be closely monitored by the on duty staff.

**5. Please describe your plan to avoid potential negative impacts to neighborhood livability such as noise, parking or garbage from your patrons.**

RCC will have an employee to patrol the immediate area, to monitor the noise, parking, or garbage from our patrons. We will also communicate with our neighbors and request that if they have any issues, they can notify us. RCC will comply with all local laws regarding parking and will notify customers of any specialized parking if there will become any on the premises.
