1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

- The company will be staffed with age verified employees
- Before having access to the showroom, where Marijuana items can be purchased , guest will be screened and their id's will be scanned to verify that individuals are 21+.
- In addition both security guard and budtender are required to verify age and identity prior to serving the customer.
- There will be visible posted signage to clarify "No persons under the age of 21 permitted."
- OLCC compliant signage will be posted " Warning , No minor permitted on premises"
- We will have compliant Posters displayed at the point of sale that state :
 - * "Keep out of reach - Marijuana can make children very sick. You can keep the kids in your life safe and healthy by storing all Marijuana in a locked area that children cannot see or reach."
 - * "Educate before you recreate - "You can possess and use recreational Marijuana if you are 21 and older. If you are younger , its illegal.
- At the time of sale, our staff will provide every patron with state issued " Marijuana Information Card"
- All staff members are trained to provide an additional verbal friendly reminder to keep all marijuana products away from children.
- We will assure all our products are appropriately labeled with the appropriate warning and are in a ASTM certified child resistant container.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

- OLCC Mandatory signage will be posted " No onsite consumption" and Marijuana and Marijuana products may not be consumed in public."

-Licensed site will have video surveillance monitors , both in the interior and exterior premises with cameras and human patrol to ensure noone is using Marijuana products on site.

-Such activity will be notified to cease and desist.

- Instances were repeated or become egregious will be reported to authority. Individual will be banned from premises.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

- Appropriate signage will be posted surrounding the perimeter. Area will be monitored under surveillance cameras and human patrol
