1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.

No persons under the age of 21 will be allowed at the licensed premises. Personnel at the licensed premises will be responsible for checking the government issued identification of any person entering the business, and any person under the age of 21 will be denied entry. A locked perimeter will be maintained at the premises at all times, even during business hours. Employees and contractors shall be subject to appropriate screening. The entire property is monitored by 24 hour surveillance. All employees will be trained regarding the laws and rules prohibiting the access of minors and other unauthorized individuals.

2. Please describe how your business will prevent cannabis products from being consumed around or near your business.

Employees will be trained and customers will be advised regarding the prohibition on consuming cannabis products around or near the business, both through appropriate signage, and through oral instructions when appropriate. The entire property, both within and outside the dispensary premises, shall be monitored by 24-hour surveillance to ensure that no cannabis is consumed on-site, and all employees will be trained in recognizing signs of on-site consumption, and taking appropriate steps to prevent the same.

3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.

A locked perimeter will be maintained at all times to prevent any unlawful access to the premises, and to prevent the unlawful diversion of products from the premises. Noise will be minimal if not nonexistent as heard from the outside of the premises, except for the comings and goings of retail customers, which will be mitigated by maintaining reasonable hours of operation. Employees will also be trained in preventing loitering by patrons if a loitering issue is observed. Parking is provided-for at the street and is regulated by the City of Portland, and shall be monitored for illegal parking by patrons. Garbage containers will be kept locked and only accessible to authorized personnel of the dispensary and the garbage service.

4. Please briefly describe your business's process to respond to and resolve complaints and/or concerns from neighboring businesses or residences.

The dispensary has a policy of addressing all concerns of residential neighbors and neighboring businesses as quickly as possible, but in no instance later than 48-hours after the initial complaint or voiced concern. If the concern or complaint is a matter directly within the control of the business, the dispensary shall take all commercially reasonable steps to eliminate or otherwise alleviate the complaint or concern to the best of its ability, and in accordance with all applicable laws and rules. If the concern or complaint is not within the dispensary's direct control, but related to dispensary operations, it shall nonetheless take all reasonable steps to attempt to contact the appropriate party or parties in order to attempt to obtain relief on behalf of the neighbor or neighboring business, including interfacing with all relevant authorities in furtherance of the above.
