**1. Please describe how your business will ensure that no one under the age of 21 is admitted, and how your business will educate patrons on the risks of marijuana use by minors.**

There are several measures employed to ensure no one under the age of 21 is admitted. There is signage posted on the entry door and interior stating "No Minors Allowed". There is a security reception person at the interior of the front door to check ID of every person entering. There are posted rules on the entry wall and again at the consumer sales areas. There is video monitoring at the entry both indoors and out that is in constant view of the security reception person. We provide extensive training to our employees on our operations and their responsibilities. We provide ongoing and required training through our contract with Portlandsterdam University. All employees are required to read and agree to follow our operations manual and employee training guide.

Educating the consumer is an important part of our duty. Each purchase will be accompanied with a 3" x 5" card printed both sides with a pregnancy warning and a keep away from children notice along with contact information for poison control. In addition we will remind adults to keep their stash locked up and out of reach of children. Large warning posters will be displayed at each Point of Sale terminal.

**2. Please describe how your business will prevent cannabis products from being consumed around or near your business.**

In addition to trained personnel, live security camera monitoring, posted rules and signage we will enforce our rule and remind customers found to be attempting to consume on or near our premise that it is illegal and they must wait until they get home. We train our bud tenders to remind customers to wait until they get home and are safe prior to consuming any marijuana product.

Our general policy is that we are responsible for taking actions to prevent or stop any illegal or unsafe incident in or around our business location or community. Our personnel are trained to respond to incidents in an appropriate manner including calling law enforcement. It is for that reason we look to maintaining relationships with local officials.

**3. Please describe how your business will prevent and address potential negative impacts to neighborhood livability such as noise, parking, garbage, or loitering from your patrons.**

We are stern about enforcement of our written policies and procedures. This includes monitoring activities in and around our business. Besides signage and constant monitoring through video surveillance our rules state there is to be no loitering and that patrons will not consume products until they get home. Any violation of our rules such as noise, illegal parking or littering among many other items is grounds for suspension of membership or service from our establishment.

It is important that we instill in our business culture that we must take preventative measures to ensure positive impacts on our community by being actively engaged and take a leading role in making it better. We are proud to say that we are members of the Chamber of Commerce, Presidents Counsel, and have been invited and participated in the Rose Festival for the last 3 years.

Here are our rules:

- Violating local and state laws – Members may not violate local and state guidelines and regulations
- Release of Liability- Member releases Stoney Only from any and all liability for medical or legal problems which may occur as a result of the use of cannabis supplied.
- The presence of any weapons or illegal drugs – No guns, weapons or illegal drugs shall be allowed in the Stoney Only.
- Acquiring or providing cannabis to anyone who is not 21.
- Any inter-state activity acquisition or distribution of medicine. All medicine acquired and provided at the Stoney Only is grown by registered members who are legally entitled to do so inside the state of Oregon. No medicine can come from outside Oregon, and it is never legal to distribute medicine outside of the state.
- Conduct and Behavior - Shoplifting, dangerous/violent behavior, serious disorderly conduct, causing a nuisance in the neighborhood, or repeated willful violations of the rules are grounds for revocation.
- Exchange of Cannabis Inside of Stoney Only – All exchanges will be conducted only by a qualified Bud Tender from Stoney Only. No grower, patient, care giver or consumer may conduct any exchanges between members directly.
- Member must have a verifiable Photo ID. All members must be verified to have possession of current ID to be allowed inside.
- Member will explicitly consent to affiliation (membership) in the Stoney Only.
- Member will obey the rules of the Stoney Only to maintain membership.
- No Minors allowed, no exceptions. There is no minor to be present in any area of a registered facility where usable marijuana or immature plants are present, even if the minor is a patient or an employee.
- Members may not be un-attended or left alone inside the facility at any time.
- No Consumption Allowed on Premise – Including edibles and topicals. Consumption, ingestion, inhalation or topical application of usable marijuana anywhere on the premises of the registered facility is not permitted.
- Always put away all of your medicine before you leave the Bud Tending area.
- No cannabis should be visible from the street at any time.
- Cell phones, recording devices and cameras are not to be used or seen in the bud tending area.
- We are a no scent environment. Please refrain from wearing any perfumes or colognes, as well as using scented deodorants, heavily scented soaps or any other strong scents.
- Please leave pets at home if possible. If pets are brought to the club, please keep them closely under your supervision and control, and make sure they don't go.
- If you have a contagious disease such as the flu or a cold, please do not visit the club.
- If you are intoxicated you will be refused service .
- Be aware that there are busy driveways which intersect the sidewalk on either side of the club.
- In case of any problems, please contact Mike Mullins, the executive director of the club. If he is unavailable, feel free to approach any other staff member and we will strive to resolve the issue and/or pass your comments along to him.
