### Approved, with the following conditions:

- Speakers are to face away from the closest residential locations.
- Stages with amplified sound are as follows: Skidmore/Mississippi 12:00 p.m. – 7:30 p.m., Shaver/Mississippi 1:00 p.m. – 9:30 p.m., Moloko Stage, 10:00 a.m. – 9:30 p.m., Fremont/Mississippi, 1:00 p.m. – 8:00 p.m., Control Voltage, 11:00 a.m. – 7:00 p.m., Spicy Spoon, 11:00 a.m. – 7:00 p.m.
- Amplification shall not be audible further than two blocks from the source of the noise.
- Sound levels will be reduced upon request.
- ALL amplification is to cease by 9:30 p.m. SHARP.
- Applicant will supply notification of the event all neighbors within a one and a half block radius. Notification will include a phone number that neighbors can call to reach the Applicant to discuss questions before the event and to report concerns of excessive noise during the event. Notice should not simply include the residents who live right on that block, but is intended to reach other neighbors who are impacted by the request for a noise variance.
- Applicant will notify the Noise Office at (503) 823-7350 of any complaints they receive. The Applicant will keep a record of how they responded to concerns raised by the community in order to report their actions back to the Noise Control Office.

### To the Applicant:

- Carry this document with you during the activity. This is not a permit to make more noise than is minimally necessary for your needs.
- Violation of the conditions of this variance constitutes grounds for revocation of the variance, and denial of future applications, and may also result in the issuance of citation(s) for violations of City Code.
- If a Police or Noise Control Officer should appear, his/her instructions will supersede this variance and take precedence.
