### Budget Advisory Committee

Every year, the City of Portland invites the public to assist bureaus in budget development for the new budget season. The Budget Advisory Committee (BAC) is one of the best avenues for direct involvement in a bureau's budget and priorities. The City of Portland Bureau of Emergency Management (PBEM) is looking for a few community members to tell us what they want to see in the following year from us.

#### *Roles of Budget Advisory Committee:*

- Increase understanding of public policies and procedures
- Increase participation in the decision making process for the city to more effectively respond to the needs and priorities of the communities reaching a broader diversity
- Provide recommendations on goals, priorities, and budget decisions

We're looking for members who are committed to building a resilient Portland and who want to ensure that all residents of the City are represented, including populations traditionally ignored or underserved, and want to ensure that the bureau is aligning funding with established goals and priorities.

#### ***What does PBEM do?***

*Disaster risk reduction through leadership and coordination. PBEM utilizes planning, training, and exercises to continually develop and sustain the city's mitigation, preparedness, response, and recovery capabilities.*

The BAC will review the City and Council guidelines for this year's budget, provide recommendations based on the Bureau's strategic direction and goals, discuss operating and program expenses, and provide feedback and recommendations.

PBEM provides both internal services to other City bureaus via coordination, training, exercise and planning, as well as community preparedness via our NET program, the BEECNs and a variety of other outreach efforts. Our budget is how we fund all these programs, and preparing the budget helps the bureau prioritize them. There are few more direct ways to impact Portland's readiness in the face of disaster than participating in our Budget Advisory Committee.

We want you to come tell us what your community – our City – needs from the Portland Bureau of Emergency Management. PBEM will make available free language assistance and auxiliary aids/services for committee members if needed.

The time commitment is to attend approximately 3 meetings, from November to March, and each meeting is expected to last up to 3 hours.
