CO - CHAIR ROBERT DYE

Bob Dye is Senior General Manager of Lloyd Center in Portland, Oregon. A native Hawaiian, a certified Shopping Center Manager, and licensed Oregon Principal Broker, Dye took Lloyd Center's helm on July 1, 2015 and has over thirty-seven years of experience in the management, marketing, leasing and development of shopping centers and mixed use properties. Over the course of his career Bob has worked with numerous municipalities and interacted with law enforcement agencies at multiple levels.

CO - CHAIR PATRICK NOLEN

Patrick Nolen was born in 1970. Due to untreated health issues including depression and anxiety he was homeless in Portland off and on from 1990 to 2011. Patrick has been both a board member and community organizer at Sisters of the Road Cafe, a board member at Empowerment Initiatives, and an advisory council member for the Mental Health Association of Portland. His ongoing interests include public health care, the housing crisis, homelessness, local politics, reading nonfiction books - especially history, and meeting new people. He's recently moved in with his girlfriend and her 9-year old son.

STEPHANIE MAYA LOPEZ, MD

Dr. Lopez graduated cum laude from the University of New Mexico with a BS in Anthropology. After that, she completed medical school and psychiatry residency training at the University of Iowa Carver College of Medicine. She then completed a fellowship in forensic psychiatry at Oregon Health and Science University. She currently teaches at OHSU, the University of Oregon Law School, and the University of New Mexico School of Medicine. She has taught about fitness to proceed evaluations for the state of Oregon's Forensic Evaluation Training Program.

CEE CARVER, PSS, CGRM

Cee Carver has worked at the Mental Health & Addiction Association of Oregon as a Peer Support Specialist, Program Coordinator, Supervisor, and currently as Director for EVOLVE West, where Cee oversees multiple programs. Cee is a member of the Washington County Behavioral Health Council, the Oregon State Hospital Seclusion and Restraint Committee, the Tri-County Committee for Managing High ED/EMS Utilization, and the Metro Area Crisis Action Council.

MARK SCHORR, LPC, CADC, NCC

Mark Schorr is a Licensed Professional Counselor, Certified Addictions Counselor and Nationally Certified Counselor. As the child of a Holocaust survivor, Mark learned about trauma and its effects at an early age.

He graduated with a Masters in Counseling Psychology from Lewis & Clark College in 1993. He has worked in multiple outpatient settings, including managing a site specializing in dual diagnosis. He was director of staff development for the largest behavioral health care provider in Oregon. He has been trained in Cognitive Processing Therapy and Prolonged Exposure, two evidence-based trauma treatments used by the Veterans Administration.

Mark developed the Workplace Trauma Support program for the region's largest mental health and addictions provider, and has personally helped out in the response to two mass shootings. As the author of multiple articles, he also provides supervision and training. He has worked for more than two decades with male and female trauma survivors. He currently is part of a multidisciplinary practice in downtown Portland at Pacific Premier Group.

TIMOTHY ROESSEL

Timothy Roessel, Advocate for Disability Rights Oregon's Protection and Advocacy for Individuals with Mental Illness, and Traumatic Brain Injury programs - spends his days in our States most secure behavioral health units, and in the streets of our communities.

A student of psychology, with experience in long-term care, law enforcement, and crisisresponse, Mr. Roessel's Protection and Advocacy authority, provides him with a unique global perspective on Oregon's behavioral health system - and our friends and neighbors who are under its care.

ROBERT McCORMICK

Bob has a bachelor's degree in Business Administration from Lewis and Clark College, 1983. He retired from the Portland Police Bureau in October 2016 after a 32 year career in law enforcement. His first ten years he worked in the Multnomah County Sheriff's Office and was transferred to Portland Police Bureau in 1994. In 1995, Bob became a member of PPB's first volunteer Crisis Intervention Team. In 1998 he was promoted to the rank of sergeant and spent time in Patrol at North Precinct, eleven years in the K-9 unit and two years in the Personnel Division.

In 2012 he was selected to help build and supervise the Behavioral Health Unit, where he worked until he retired in 2016. Bob helped to develop the Enhanced Crisis Intervention Team and was a team member during this period. In 2017 he began working at Oregon Department of Public Safety Standards and Training's Basic Police Academy as a part time instructor in their mental health curriculum.
