PCCEP Retreat Debrief	<ul style="list-style-type: none">• PCCEP Summer Retreat Debrief:<ul style="list-style-type: none">○ Opening question allowed people to shared what they're thankful for.○ Discussed communication methods, the scope of work on the committee, the PCCEP plan and codifying PCCEP.○ What was going well on the committee.○ People speak freely during retreats which helps understand others perspective.○ More attendance and engagement from the Portland Police Bureau (PPB) at PCCEP meetings in preparation with questions for the public.○ Clarifying questions were shared.○ Best ways to move forward as a committee were addressed.○ PCCEP retreats are schedule quarterly; winter, spring, summer and fall.

Youth Interviews	<ul style="list-style-type: none">● Next steps for PCCEP youth application interviews:<ul style="list-style-type: none">○ Currently there are two youth candidates who have applied.○ Current youth members were invited to sit on the panel. Clarification is needed around if this is a conflict or not.○ The current youth members Taji and Britt are open to staying on until meetings are no longer virtual via Zoom.
Restorative Justice Recommendation	<ul style="list-style-type: none">● Restorative Justice recommendation - where do we go from here?<ul style="list-style-type: none">○ Recommendation passed on June 23rd during the PCCEP full board meeting.○ Meeting with the Mayor's office was canceled (June 26th) due to the protest that occurred at the North precinct.○ A working date for a reschedule meeting has been shared for July 16th. No confirmation has been set.○ Goal is to discuss next steps around the restorative justice recommendation under sections 1 and 2.○ Met with the District Attorney and he is for the recommendation specifically regarding section 3 of the recommendation.○ A response is needed in real time from the Mayor's office on who in his office is going to work on it and next steps.○ Still working on how to flash out section 3 to fit the reality of the real world.○ Section 1, 2 and 3 are all different and should be cared for differently regarding on the focus of each.● Public comment – will this recommendation help clear juvenile records? Once there's a record it's difficult to get rid of it. The goal is to not have records and for youth not to be put in jail for low level crimes.● Trainings final issues with overtime limitations are expected.● We must figure out ways to make trainings work and engage community partners.● Closing remarks – something you are thankful for?
