- **Recommendation of Acknowledgement:** PCCEP and the Community request that PPB send a formal letter within 7-10 business days (Or Less) acknowledging the passing of an individual who has been involved in a lethal force event, expressing to the family the remorse for their loss by the City. We



also recommend that a follow up visit be done, by trained staff to provide the family to support services for their loss if they so choose. 1/26/21

While my contribution to PCCEP in an official capacity is coming to a close, I look forward to showing support and participating in dialogue in future meetings as a community member.

VI. PCCEP CHALLENGES

Maintaining Adequate Pool of Qualified, Diverse Alternates

- PCCEP has had 1 member resign in Q1 2021, and 3 alternates either not respond to efforts to contact or ask to be removed as an alternate. PCCEP plans to make recommendations for appointment to the general committee and alternate seats in Q2 of 2021.
- PCCEP Staff sent out a recruitment ad that called for people from a variety of communities throughout Portland to apply to the PCCEP. Within a few minutes of the recruitment being disseminated, the MHA requested that it be amended to include those with lived experience with mental illness. PCCEP staff immediately amended the recruitment to reflect the request.
- Like much of the world, PCCEP is unable to conduct in-person outreach due to the ongoing pandemic.

PCCEP Website

- The navigation of the PCCEP website remains difficult in the midst of the citywide website migration. PCCEP's move to the new website is TBA.

Timely Responses

- The PCCEP needs more timely responses to recommendations as well as documented next steps if and when a recommendation is adopted by the Mayor



and/or Chief of Police. Recently, there has been a concerted effort from both the Mayor's Office and the PPB in this regard.
