**Single Room Occupancy (SRO) and Group Housing Rents - CPD 94-01**

**\* SRO Housing**

- If the unit has neither food preparation nor sanitary facilities, or only one, rents may not exceed 75% of the FMR for a 0 bedroom (Efficiency) unit (the "lesser of" standard does not apply).
- If the unit has both food preparation and sanitary facilities, "High HOME Rents" and "Low HOME Rents" for a 0 BR (Efficiency) unit apply.

**\*\*Group Housing**

- Rents are based on the Fair Market Rent (FMR) for the unit size (number of bedrooms).
