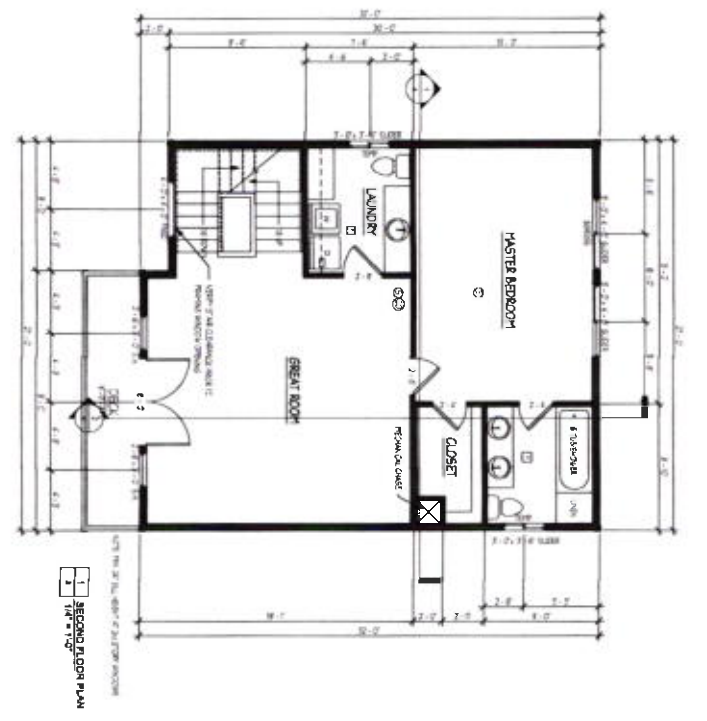

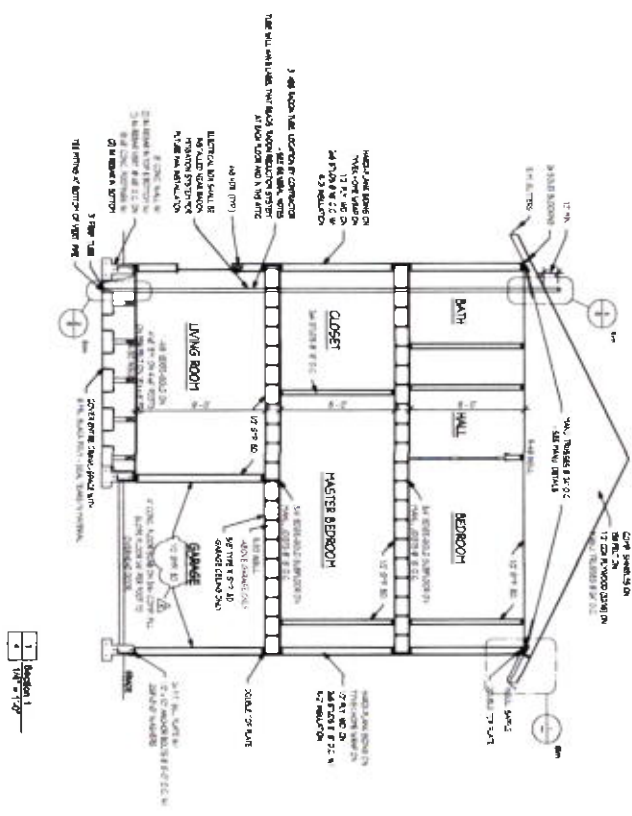
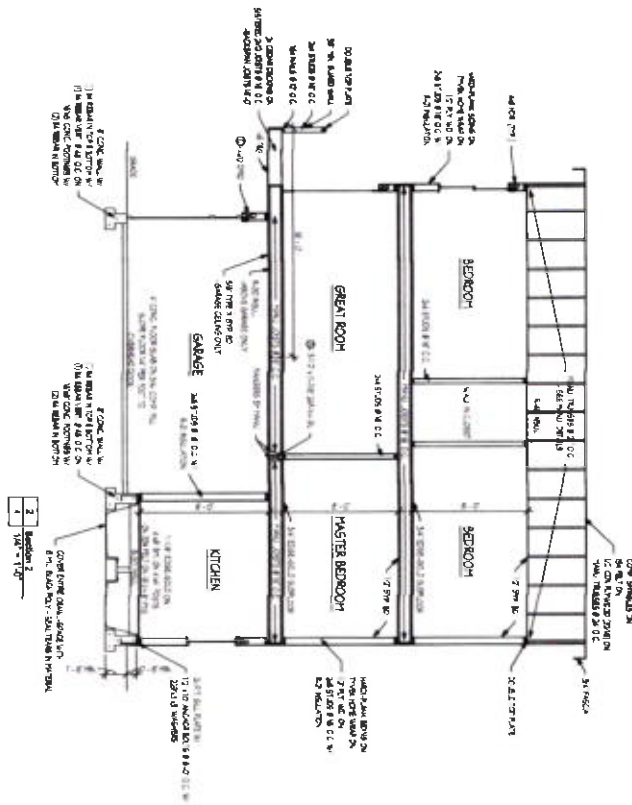
SECOND FLOOR AREA - 1200

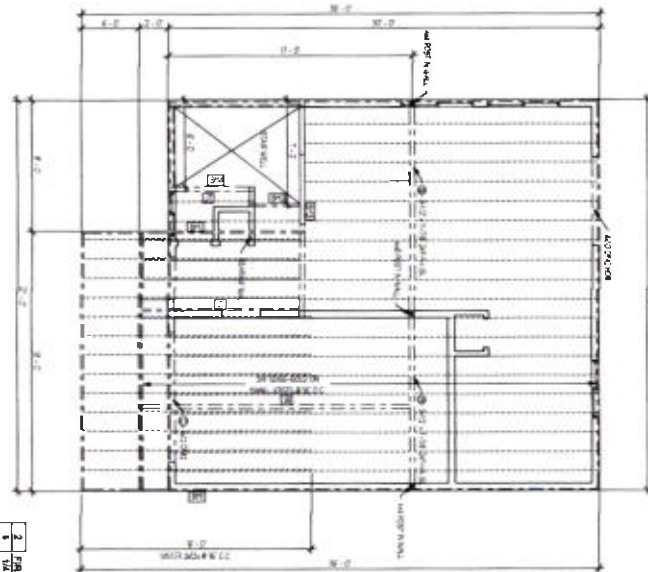
1 SECOND FLOOR FRAMING
