Definitions:

Be on the Lookout for: An individual or vehicle matching the description of a suspect or suspect vehicle in a recent investigation. This information may have been in a written report, transmitted by radio or from personal involvement in the investigation or incident.

Criminal Code: A visible violation of Oregon Criminal code conducted by an individual or group of individuals in the presence of an officer. This also may be the officer confirming what he/she believes to be violation of Oregon Criminal code.

Municipal Code: A visible violation of Municipal Code conducted by an individual or group of individuals in the presence of an officer. This also may be the officer confirming what he/she believes to be a violation of Municipal code.

Vehicle Code: A stop initiated as a result of the operation of a motor vehicle in violation of the Oregon Statutes dealing with the condition or operation of a motor vehicle on public or private lands and rights of way.

Vehicle Inspection: A stop initiated with the intent to carry out a PUC inspection on a commercial or marine vehicle to enforce Public Utilities regulations on the operation and condition of the commercial or marine vehicle.
