REGJIN UPDATES

Privatization SOP vote

Jim Hansen of the Clark County Sheriff's Officer requested to add "cases involving other Law Enforcement Agency Members" to the list of cases which are acceptable to privatize on SOP #8

Cmdr. Dave King of Vancouver PD made a motion to approve SOP #8 Case Privatization with the added line "cases involving other Law Enforcement Agency Members" to the list of cases which are acceptable to privatize.

Lt Dave Frisendahl of Tigard PD seconded the motion.

Vote was passed unanimously. (See Attached final version of SOP #8)

Inquiry Only

Tammy Mayer proposed 3 defined areas of Inquiry Only (LE, Criminal Justice, and Public Safety). She proposed moving forward with Inquiry Only access for the Law enforcement organizations.

- **FBI - OR and WA**
- **ATF**
- **OSP**
- **IRS**
- **ICE**
- **DEA**
- **EPA**
- **OHSU Police**
- **VA**

Of those listed, only FBI, OSP and VA police responded to her email regarding moving forward with their access. There was an ongoing discussion about sharing narratives with outside law enforcement organizations.

- It was asked what is currently viewable on LinX NW in terms of narratives.
- Discussion about the audit trail to determine who has viewed what information. Currently the system is set up to be able to research this information but not to send automatic notification if a case has been viewed.
- A request was made to add language to the Inquiry Only IGA that would reflect that any case information gleaned from RegJIN would need to be officially requested from the owner of the information prior to its official usage so that the owning agency can track who has been officially authorized to use the report.
- Lt. Roy Rhine of Ridgefield PD made a motion to approve any approved law enforcement organizations for full viewing access (Narratives and Attachments) but to include the admonition that an official request to the agency who is the owner of the record for the official use of the record. Cmdr. Dave King of Vancouver PD seconded the motion. Vote was passed unanimously.
- Cmdr. Dave King of Vancouver PD made a motion to approve FBI (both OR and WA), OSP, and the VA as approved law enforcement organizations. Lt. Roy Rhine of Ridgefield PD seconded the motion. Vote was passed unanimously.

- Action Item – Need a written definition of a law enforcement organization/agency and language for the written admonition about contacting the agency that holds the report prior to its official use. This should be made part of SOP #9 *Inquiry Only*. – Program Manager

SUBJECT: Case Privatization

DEFINITIONS: Private – Cases that will only display a case number and a contact person to request information about the case.

Private Invisible – Cases that do not appear at all when searched.

PURPOSE: To define standard conventions for case privatization.

POLICY: It is the policy of the RegJIN User Board to maintain a high level of transparency within the case management system and to only privatize information that is of such a critical nature that its potential release could jeopardize a major investigation, and/or harm victims or witnesses. Over privatization lowers the utility of the system and renders it more difficult to manage. Privatized cases are still subject to public records law.

RESPONSIBILITY It is the responsibility of each regional partner to monitor their agencies privatization usages.

PROCEDURE: The follow are a list of cases that are acceptable to privatize.

- Sex Assault
- Gang Cases
- Elder Abuse
- Drug Trafficking Organization Cases
- Criminal Internal Investigations
- Child Abuse
- Any Measure 11 Case
- Bias Crime Cases
- Cases involving other Law Enforcement Agency Members

Eligibility for privatization does not automatically warrant privatization. Agencies should strive to privatize only cases where the information is sufficiently critical or sensitive that it could jeopardize the investigation or the safety of an individual, AND, only the part of the case that applies. It desirable to privatize certain narratives instead of the entire case.

Un-privatized cases do not release an agency from its due diligence to comply with their state's public records laws.

Private Invisible Cases are for court ordered sealed records or Internal Criminal cases only and must be designated by the Commanding Officer of the division handling the case.

In utilizing privatization features, it is imperative to include the appropriate supervisors/commanding officers, records staff, and members of the prosecutor's office as part of the group who can view the case. Each agency is responsible to set up the appropriate routing and notification to ensure cases are not rendered inaccessible by those who need to view them as part of their duties.

Cases which are privatized will be reviewed at least yearly to determine if there is a persistent need for the privatized portion of the case to remain private. Such reviews should be documented as part of the case.
