3. TYPES OF HEARINGS - WHO CAN REQUEST - TIMELINE

Certification Hearing

A certification decision may be challenged by a candidate who has received a determination letter refusing certification or an opponent of a candidate who has been granted certification. A written request must be filed using this form no later than 7 days after the mailing of the determination letter. Certification Hearings shall be held not later than 7 days after the hearings request is filed.

Matching Funds Hearing

A matching funds decision may be challenged by a candidate who has received a determination letter granting or refusing matching funds or an opponent of a candidate who has been granted matching funds. A written request must be filed using this form no later than 7 days after the mailing of the determination letter. Matching Fund Hearings shall be held not later than 7 days after the hearings request is filed.

Penalty Hearing

A proposed penalty may be challenged by a candidate, person or political committee who has received a notice of proposed penalty. A written request must be filed using this form no later than 7 days after the mailing of the notice of proposed penalty. Penalty Hearings shall be held not more than 14 days after the hearings request is filed.
