

This week, we received 666 new campsite reports identifying roughly 115 campsites throughout the City. Of these new reports, 245 were of people living in vehicles. Additionally, 174 of the reports we received this week were reports of camping on Oregon Department of Transportation (ODOT) properties and rights-of-way, 2 were of camping on Union Pacific Railway or BNSF right-of-way, and 19 were of camping/squatting on private properties.
