WEEKLY CAMPSITE REPORT

March 29 – April 4, 2021

Last week, the Homelessness and Urban Camping Impact Reduction Program (HUCIRP):

- Conducted 9 campsite removals and 21 campsite cleanups.*
 - *Campsite removals indicate personal property has been removed and placed in storage. Cleanups mean no personal property was collected, only what was identified as garbage in addition to other biohazardous materials.
- Completed approximately 195 assessments—engaging with people living in camps, collecting garbage and biohazardous materials, and coordinating with service providers.

This week we received:

1598 new campsite reports identifying 112 active campsites throughout the City.

Of these reports:

- 633 were reports of people living in vehicles.

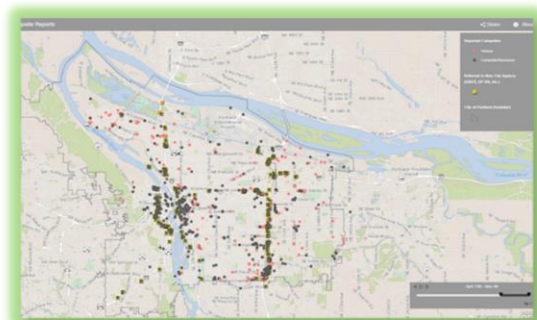

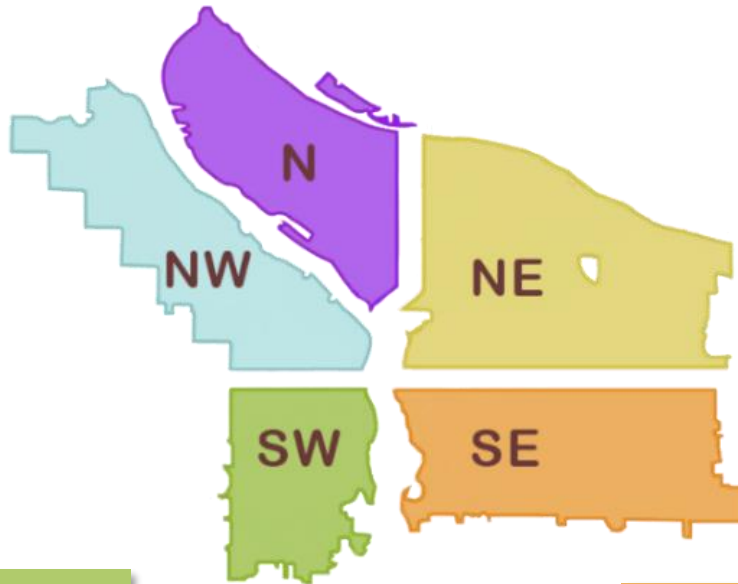
