## Application attachment requirements

Attach manufacturer's information for proposed bicycle rack, including:

- Image or sketch of rack, with rack dimensions, rack material, and finish
- Security bolt type (required: stainless steel pin hex button socket security bolts, or approved equal)
- Proposed installation information if surface is not concrete

Attach an 8.5" x 11" site plan that calls out a minimum of the following information:

- Proposed location of bike rack and placement of bicycle(s). Please show each bicycle footprint as a 6 ft long by 2 ft wide shaded area. *Most bike racks accommodate two bicycles side-by-side and thus require a footprint of 6 ft by 4 ft.*
- Distance between proposed rack and any existing street furniture in right of way (such as trees, sign poles, mailboxes, corner curb cuts, light poles, mailboxes, trash cans, newspaper racks, tree wells, etc).
- Existing or proposed/future permitted café seating or vendor areas (in order to ensure that minimum pedestrian through zones are maintained).
- North arrow, street names, on-street parking adjacent to proposed rack, and sidewalk width, including information about required minimum through zone.
