MAINTENANCE PARKING PERMIT APPLICATION

The Maintenance Parking Permit is an annual permit for the use and occupancy of metered zones by commercial vehicles ONLY while legitimately engaged in maintenance, service, or repair work that necessitates that the vehicle be near the jobsite.

2. PERMIT INFORMATION

Permit will read:

WHILE PERFORMING MAINTENANCE WORK, MAY PARK IN ANY METERED SPACE (EXCEPT 15 MINUTE) WITHOUT TIME LIMIT, 8 AM - 7 PM ALL DAYS. MUST HAVE FIRM NAME ON BOTH SIDES OF TRUCK OR VAN. MAY NOT PARK IN RESTRICTED ZONES OR WHERE GOVERNMENT VEHICLES ARE PROHIBITED.

Permits are \$1,380 each annually (July 1 – June 30).

3. PERMIT USE AND CONDITIONS

- Permit holder may, while performing maintenance work, park in any metered space (except 15 minute) without time limit, 8 a.m. – 7 p.m., all days. May not park in restricted zones or where government vehicles are prohibited.
- **This annual permit may not be used at building remodels or new construction.** The City of Portland will revoke the permit of any firm found using their permit in these circumstances.
- Permanent or magnetic signs, with the name of the company in letters at least 2” high must be displayed on both sides of the truck or van.
- This permit may not be used in Truck Loading Zones or at any curb space not regulated by either a parking meter or pay station.
- This permit must be clearly displayed in the lower center of windshield when service is performed. This permit remains the property of the City of Portland and must be surrendered upon demand by any authorized officer. It is unlawful to display this permit in any vehicle other than that which it is issued, and then only when the vehicle is parked as specified above. **THIS PERMIT MAY NOT BE USED IN COMBINATION WITH OTHER PERMITTED PARKING.**
- Violators of these conditions shall be penalized as follows:
 - 1st violation: Penalty as imposed by Court Authority
 - 2nd violation: Penalty as imposed by Court Authority, plus 10 days suspension
 - 3rd violation: Penalty as imposed by Court Authority, plus 30 days suspension
 - 4th violation: Penalty as imposed by Court Authority, plus revocation of permit
- Failure to surrender a suspended permit within 10 days of the date of our notification to you will result in the cancellation of that permit for the remainder of the year. **Continued noncompliance may result in an examination of whether permits will be issued to you in the future.**
