The **"CONSTRUCTION PRODUCTS LIST" (CPL)** is a list of products which have been evaluated and/or specifically used by the **City of Portland Bureau of Environmental Services, Bureau of Transportation, and the Portland Water Bureau.** (Click Blue Text)

The **"QUALIFIED PRODUCTS LIST" (QPL)** is a comprehensive list of products which have been evaluated and/or used by the **OREGON DEPARTMENT OF TRANSPORTATION (ODOT).** (Click Blue Text)

The CPL contains products specific to the City of Portland. The CPL and QPL are not identical. If the product you wish to use is **NOT listed on the CPL but IS listed on the ODOT QPL, you must submit the QPL information to the Engineer for product approval.**

The "CONSTRUCTION PRODUCTS LIST" is made up of three types of lists:

1. The **QUALIFIED LIST – "Q"** is for products that have been reviewed and found to be suitable for use in a specific category. Job control testing may still be necessary. Consult the ODOT "Nonfield-Tested Materials Acceptance Guide," the ODOT "Field-Tested Materials Acceptance Guide," and the Project Specifications.
2. The **APPROVED LIST – "A"** is for commercially available products having a low consequence of failure. These products are only usable for appropriate applications. May Require a Field Inspection Report which states existence on the Approved List and recognition of the product. No additional sampling or testing is needed.
3. The **REJECTED LIST – "R"** lists products not allowed for any use.

The use of all products is restricted to the category in which they are listed. Products should be used and installed as the manufacturer

## Traffic Control Devices Notice (4-7-2011)

The American Association of State Highway and Transportation Officials (AASHTO) recently published the *Manual for Assessing Safety Hardware* (MASH). MASH is an update to and supersedes NCHRP Report 350.

Requirements in Section 1408 of SAFETEA-LU stated that "The Secretary, in cooperation with the Association [i.e., AASHTO], shall publish updated guidance regarding the conditions under which States, when choosing to improve or replace highway features on the NHS, should improve or replace such features ... ". The AASHTO/FHWA Implementation Plan was developed to satisfy that requirement.

Category 1: Plastic Tubular Markers, Plastic Barrels.

Category 2: Portable Sign Supports, Tripod Mounted AFAD's, Type 3 Barricades, etc.

Category 3: Impact Attenuators, Guardrail, etc.

Category 4: Trailer Mounted Sequential Arrows, Trailer Mounted Message Boards, Trailer Mounted AFAD's, Trailer Mounted Flagger Station Lighting etc.

It is the responsibility of the Contractor to ensure they use a product that complies with the appropriate requirements.

Use of the listed products shall be restricted to the category of use for which they are listed. Unless otherwise specified, the Contractor shall install all products as recommended by the manufacturer. The Contractor shall replace qualified products not conforming to Specifications or not properly handled or installed at Contractor expense.

As stated in the City of Portland Standard Construction Specifications Section 00160.05, the Construction Products List (CPL) is a list of manufactured products available on the market (shelf items) that BES has evaluated and found suitable for specified use in construction.

The current version of the CPL at the time of Bid Opening is the version in effect for the Project.

The Engineer may approve for use a conditionally qualified product, or a product qualified for inclusion in a later edition of the CPL, if the Engineer finds the product acceptable for use on the Project. Use of listed products shall be restricted to the category of use for which they are listed.

The Contractor shall install all products as recommended by the manufacturer. The Contractor shall replace qualified products not conforming to Specifications or not properly handled or installed at the Contractor's expense.

Choosing a product from the CPL does not alleviate the Contractor from its responsibility to follow the requirements of the Contract. Use of all other products and 'or approved equal' products not included on the CPL requires a standard construction submittal for review and approval.
