PORTLAND FREIGHT COMMITTEE

Summary of 2016 PFC Priorities

Rivergate Overcrossing Project

- ✓ Received **\$7.3 million** © from joint City/Port TIGER grant funding requests for project construction.
- ✓ Solicited consultant RFQs for final engineering and design to begin in 2017 with construction in 2018/19.

Heavy Vehicle Use Tax (HVUT) Work Group and Project Selection

- ✓ PFC members and freight planning staff participated in the Heavy Vehicle Use Tax Work Group which is estimated to generate \$10 million over 4 years with 56% for street maintenance and 44% for safety projects.
- ✓ PFC members appointed to Fixing our Streets Oversight Committee to review spending priorities.

Status of Previously Funded Capital Freight Projects

- ✓ North Burgard/Lombard-Time Oil Road Project (RFF funded) – project construction in 2017.
- ✓ NE 47th Avenue Improvement Project (LID and SDC funded) – project construction in 2017.
- ✓ NE MLK/Columbia Blvd Intersection Improvements (RFF funded) project construction in 2017.

2019-21 Regional Flexible Funding (RFF) Freight Projects

- ✓ Submitted two RFF freight project funding applications: 1) Central Eastside Access and Circulation Project (\$3,000,000 request), and 2) Columbia Blvd ITS Improvement Project (\$600,000 request). Metro ranked Central Eastside as their 2nd regional freight priority and Columbia ITS 4th out of four total funding requests.

Regional Over-Dimensional Truck Route Study

- ✓ PFC members and freight staff participated in seven Project Management Team and Stakeholder Advisory Committee meetings to review and provide feedback on consultant work products and recommendations.
- ✓ 90 percent of project work tasks have been completed with the Final Report expected by January 2017.

Central City Truck Parking and Loading Plan

- ✓ Participated in technical work group meetings with PBOT Parking staff and project consultant team.
- ✓ Completed Truck Parking and Loading Plan final report in November.

Regional Freight Strategy Update

- ✓ PFC members and freight staff participated in Regional Freight Advisory Committee. Guided development of Key Freight Trends and Logistics Issues report and system performance measures for the 2018 RTP Update.

Oregon Freight Advisory Committee

- ✓ PFC members and freight staff continue participation in bi-monthly OFAC meetings and sub-committees.
- ✓ Participated in Oregon Freight Intermodal Connector Study to identify strategic connectors in the Metro region.
