SeQuential Biodiesel Production Process

Kevin Kuper and Frank Giustino from SeQuential lead a discussion on their biodiesel production process and uses in the region. See company website: http://choosesq.com. Action requested: Informational Item

Comment: Have you approached transit provides such as Trimet?

Response: Yes, talking with them and making us known.

Comment: Talk about distribution options, do you have a presence?

Response: We are in NW Portland, Front St and McCall. 400,000 gallons. Full production plant in Salem.

Micro terminals, mostly in Seattle, Portland, and Salem. We can get tanks for your service.

Comment: Storage capacity needs for your local offices? City just passed a ban on fossil fuels.

Response: It does impact us, but there's some flexibility. No won't need additional storage and our current space can support future needs. Production standpoint and will continue to grow in our current position. Shelf life is a year just like diesel.

Comment: High clout point, any advancements to lower?

Response: Biodiesel directly related to C-tain, 0 to 1 today; working with ODOT this winter and have been successful in previous winters. Having stab heaters, right blend, and other mitigation techniques.

Washington County Freight Study

Erin Wardell from Washington County and Phil Healey from the Port of Portland provided an overview of the key finding and recommendations from the recently completed Washington County Freight Study.

Comment: Data important on the major arterials?

Response: We are just highlighting those with high percentages by volume

Comment: Look at hazardous materials routing, was that added your analysis?

Response: It did come out during the interviews, 217 is used as an alternative, main reason because of

congestion and that is true about Cornelius Pass route.

Comment: Did you classify trucks by type?

Response: County has annual count of trucks, collected class 5 and above.

Comment: How did you define truck vehicle?

Response: Comes out NPRS National. It does not catch smaller delivery vehicles. There are some limitations in

our study. Study highlights I5 as an important route.

Comment: What does the county do to slow down and catch up for peak congestion? Response: Depending on zoning would determine what mitigation and requirements needed for new investments and development.

PFC Chair/Vice Chair Nominating Subcommittee

The PFC Bylaws stipulate that a subcommittee shall be formed biannually at the October meeting to select a committee Chair and Vice Chair and that the subcommittee shall report back at the November meeting.
