<b><u>Central City in Motion (CCIM) (70 minutes)</u></b>	<b>6:10</b>
PBOT project manager Gabe Graff will share results from recent CCIM outreach, including the most recent online open house, and share how it has informed project design and priorities. He will present early designs for eighteen clusters of pedestrian, bicycle and enhanced transit projects being considered for prioritized funding and discuss next steps.
