- This form is to be used to request a permit to permanently attach items to street trees, including ornamental lighting. "Permanently" is defined as 6 or more continuous months in a 12-month period.
- There is a non-refundable fee of \$264 per street tree attachment application. You may include multiple sites in one application.
- Fill out the application completely and legibly. List each address and the number of trees to be permitted at each address.
- Applicants must also submit a Letter of Guarantee against loss or damage to City trees.
- Submit the completed application, Letter of Guarantee, and \$264 fee in **one** of the following ways:

 - Include a check made out to City of Portland

 - Pay by check, cash, or credit or debit card (Note: there may be a wait time at the Development Services Center)
