



## NEIGHBOR PLANTING CONSENT FORM

### Instructions

**This form is to be used when you are required to replant as a condition of a Tree Removal & Replanting Permit and you wish to replant in your neighbor’s right-of-way.**

1. Talk to your neighbor and get verbal permission to plant street trees on their property. Let your assigned Urban Forestry Tree Inspector know the neighbor’s address and the number of trees you wish to plant on that property.
2. The Tree Inspector will inspect the site, mark the curb next to where the trees are to be planted, and send the applicant the Approved Street Tree Planting List that is appropriate for the planting space. The Tree Inspector will confirm how many trees can be planted in the neighbor’s right-of-way.
3. Talk with your neighbor to select which trees to plant from the Approved Street Tree Planting List.
4. Once you have selected the species and number of trees to plant, fill this form out completely and legibly. All information is required. Incomplete forms will be subject to delay.
5. Submit the completed form to the Tree Inspector assigned to your case or by *one* of the following ways:

    - Note: there may be a wait time at the DSC

Note: This form must be submitted before the Tree Removal & Replanting Permit will be issued.

### Tree Planting Standards

- Tree species should be selected from the Approved Street Tree Planting List that is appropriate for the planting space. Find the lists online at [www.portlandoregon.gov/trees/plantinglists](http://www.portlandoregon.gov/trees/plantinglists) or by contacting the Tree Inspector assigned to your case.
- Newly planted trees must meet the minimum caliper size (below). Caliper is defined as the diameter of a tree trunk, in inches, measured 6 inches above the tree’s natural ground line.

Development type	Street tree minimum caliper size
One and two family residential	1.5 inches
Multi-dwelling residential	2 inches
All others	2.5 inches

- Conifer trees must be a minimum of 5 feet in height at time of planting.

- Newly planted trees must be watered during the dry summer months (May to October) for at least the first two to three years. Each tree will need approximately 15 gallons of water once a week. Trees should be watered slowly to penetrate the soil deeply.
- Trees must survive for at least two years after planting or must be replaced by the permit holder.

**Statement of Fact:** By signing or initialing, I certify that the facts and information set forth in this application are true and complete to the best of my knowledge. I understand that any falsification, misrepresentation or omission of fact (whether intentional or not) in this application or any other required document, as well as any misleading statement or omission, may be cause for revocation of permit, regardless of how or when discovered.

**Statement of Compliance with City Code:** By signing or initialing, I agree to comply with City of Portland Code Title 11. I understand that submitting an application does not entitle me to a permit, and I must have the permit in hand before beginning any work. Failure to obtain a permit or violating the terms of a permit may result in civil penalties of up to \$1,000 per violation per City Code Title 11. I agree to hold harmless the City of Portland, its agents, officers, and employees for any damage or injury caused by reason of planting, placement, maintenance, or removal of trees.

**Statement of Intent to Plant and Establish Trees:** By signing or initialing, I understand that replanting is a condition of a tree removal permit. I agree to meet the City of Portland's street tree planting standards ([www.portlandoregon.gov/trees/treeplanting](http://www.portlandoregon.gov/trees/treeplanting)). I understand that I am responsible for the successful establishment of the replanted trees.
