## Outdoor Rebate Eligibility Requirements

- The applicant must have an active Portland Water Bureau water account in good standing.
- Only qualifying irrigation hardware is eligible for the rebate. Review the list of qualified hardware on our website: [www.portlandoregon.gov/water/rebate](http://www.portlandoregon.gov/water/rebate).
- Rebates are for qualifying equipment only, and will not cover costs for installation.
- Rebate applications must include a copy of a sales receipt from a retailer or supply company that shows the purchase date, purchase price, manufacturer, and model information.
- Rebates are for retrofits and new construction.
- The application must be received within 90 days of purchase date.
- Rebates are available to all customer classes.
- The total rebate will not exceed the receipt amounts.
- Rebates apply to in-ground irrigation systems with automatic controllers.
- Backflow assemblies are required to be installed on the water service connections to all landscape sprinkler systems. Backflow assemblies must be tested annually by a state-certified backflow assembly tester. Backflow inspections must be current to receive a rebate. - There is a \$3,000 rebate limit per entity per fiscal year.

## Follow These Steps to Obtain Your Rebate:

- 1 Purchase qualifying hardware.** A list of qualifying devices can be found at [www.portlandoregon.gov/water/rebate](http://www.portlandoregon.gov/water/rebate). Rebates are for qualifying equipment only and will not cover costs for installation. Be sure to keep all receipts.
- 2 Complete upgrades.** Irrigation hardware must be installed at the property associated with the Portland Water Bureau account. Random inspections may occur.
- 3 Complete, sign, and submit the Outdoor Irrigation Rebates Form** (see reverse). Submit with the equipment sales receipts or invoice.

- 4 Receive your rebate.** Rebates will be posted as a credit to the water, sewer, stormwater account on record for the property. Rebates are processed as they arrive, but it may take a full billing cycle before the credit is posted to the account.
