Ewe Putain Pekin Konik an Portland a kuna napenoon lead non konikin uun non ekkoch iimw. Lead mi tongeni epwe efisata osukosuken watten semmwen, akkaewin ngeni mi pwopwo me semirit. Kose mochen kopwe anneaechu ei poraus ren omw kopwe sinei met en mi tongeni feeri omw kopwe ekisaano lead non unumom konik.

FEIENGAWEN LEAD

Lead mi tongeni epwe efisata osukosuken watten semmwen ika pwe a kon watte mi tonong non inisum seni unumom konik me pwan ekkoch mettoch me wor lead non. Mi tongeni an epwe efisata osukosuken tupwu me kitni, me pwan osukosuka feerutaan ekkewe red blood cells ekkewe re awora oxygen ngeni kinikinin unusen inisich. Watten efeiengawen an wor lead ngeni menukon, kukkun semirit, me mi pwopwo. Sou sinenap (ika scientists) ra kuna pwe efeiengawen lead mi akukkunaano tufichin sine ren semirit. Ekkewe mi mwuk mi wor ar osukosuken kitni me cha feita ir mi tongeni wor ar osukosuk ren chok mwo ekis lead nap seni ekkewe mi mwuk ese wor ar semmwen. Lead e kan tonong a nomw non chuu, iwe mi tongeni an epwe pwau murin fite ier. Nupwen pwopwo, ewe menukon non nuken ewe inenap epwe tongeni angei lead seni non chuun ewe inenap, minne epwe tongeni angawa tupwuan.

IA LEAD A FEITO ME IA

Lead mi wor non sakkopaaten neni ika pisek. Ina mwo ika lead ese sou pwa non ach konik me **ese pwa pwe mi wor lead non ekkewe nenien fetanin konik**, lead mi chok chiwen tongeni wor non neimw. Non Portland, lead e tonong non konik uun seni piipin minen nomwun paipen konik mi wor lead non. Ekkei piipi mi pachenong ekkewe piipin iosechun an kapach fengen ekkewe paip e feer seni kapa (copper) - napengeni mi wor non **ekewe iimw re keu ika feer paiper non 1970 ngeni 1985** - me piipin piraas (brass) me nenien kusun konik. Lead non paipen konikin non imw mi tongeni an epwe marono non en konikin uun nupwen en konik a nomw non ew paip non fitu awa, ren nepwin ika nupwen niwiniti immw seni angang ika sukun.

Non Portland, watten feiengawen lead e feito seni peinitin imw wor lead non, piipin non iimw, pwun, me ekkewe nenien fetanin konik. Lead mi pwan tongeni pwa non ekkoch mettoch ren toys, ekkewe minen makeup me ekkewe mettoch e feer seni pottery.

- 1. Okusu konik an epwe nimetau lead** Ika ese mwo piin kus konik non fitu awa, akkoum okusu konik non ukuukun 30 seken ngeni 2 minich ika tori an a pateno me mwen omw kopw un ika aea ne kuk.



2. **Kopwe aea konik mi pat mi minafe ne kuk me fer unumen menukon titi.** kesapw aea minen kuk me un konik seni ewe nenien kusun konik mi pwichikar; lead ekan mecheres an nomw non konik mi pwichikar. Kesapw aea konik seni nenien kusun konik mi pwichikar ne fer unumen menukon titi.
3. **Kesapw chenupwichi konik omw kopwe minaau lead me non.** Chenupwichi konik ese minaau en lead.
4. **Ekiiki omw kopwe aea romorom (ika filter).** Cheki ika mi ekisaano lead - ekkoch filter rese ekisaano. Chemeni kopwe tumunu me sissiwini omw filter ussun met me eureur seni chon feeri ren omw kopwe anisi tumunun unumom konik. Keeri ika poraus ngeni NSF International won **800-NSF-8010** ika www.nsf.org ren porausen eureur won filter ika romoromen konik.
5. **Cheki noumw semirit ika menukon ren lead.** Eisini noumw tokter ika keeri ewe **Nampaan Pekin Lead** omw kopwe eis ifa ussun an noum epwe chek ren lead. Keukun lead non cha ina chok ew anen an epwe chek ika mi wor feiengawen lead non noumw iwe.
6. **Cheki konikin uun ren lead.** Keeri ika poraus ngeni ewe **nampaan Pekin Lead** won www.leadline.org ika **503-988-4000** omw kpwe eis ifa ussun omw kopwe angei**ESE KAME** chekin lead non konik.
7. **Sou nimeti mesen omw iwe nenien kusun konik.** Piipii mi wor lead non seni minen iosechun kapach fengenin paip ika nenien fetanin konik non imw mi tongeni mwech non mesen ewe nenien kusun konik. Ika ke sou nimeti iteitien murin fitu maram epwe nimetaano ekkei piipii pwan ekisaano feiengawen lead.
8. **Ekiiki omw kopwe kame pisek mi kukkun lead non.** Seni ewe ier 2014, meinisin paip, me kinikinin me pisekin fetanin konik repwe kukkun seni 0.25% lead non. Nupwen kame minafeen ekkei sakkun pisek, Mi auchea an chon kame repwe kut ekkewe mi kukkun lead non.

Fan run non ew ier ewe Putain Pekin Konik an Portland e kan cheki lead me kapa on konik mi kus non nap seni 100 imw. Ekkei imw mi fat pwe epwe tongeni wor lead seni minen iosechun paipen konik iwe epwe pwan watte lead non konik. Pungun ewe chekin lead seni non ewe Fall 2017 re ukuukun 17 ne ew billion.
